- 013 Crews reporting at Clearing must contact the Yardmaster in charge of the yard where the outbound train is built within 10 minutes of arrival at Clearing. A job briefing, to include a discussion of the route to be used to move power to the train, must be conducted within this conversation.
- 014 Crews reporting at Clearing for trains on the main lines or at outlying yards must notify the Train Dispatcher upon arrival.
- 015 Crews picking up power at the Diesel Shop must notify the Shop Foreman before boarding the locomotive consist by radio or phone (708) 496-4067.
- 016 Crews picking up locomotives from any location are expected to be moving to the train with 30 of arrival. Crews must report to the employee in charge of the location when they are unable to comply with this instruction.
- 017 Trains destined Clearing off the CSX Elsdon Subdivision must contact the BRC South Dispatcher prior to passing 103rd Street, MP DC 15.5.
- 018 Trains departing Clearing must remain on Channel AAR 057-057 until roll by inspection has been completed by the BRC Marker Man.
- 019 Trains inbound to the West Receiving Yard, with permission from the East Yardmaster to enter the yard, will not select inbound routes until the head end of the movement passes the sign located at 65th Street, MP 4.40F.
- 020 At Clearing Yard, when necessary to cut the Central Avenue Yard Access Crossing on 7 Lead, 8 Lead, or the South Thoroughfare, cut the crossing by not less than 300 feet on either side.
- 021 22nd Street Yard tracks 4 and 5 are OOS.
- 022 Automatic crossing warning devices are active at the Canal Bank Road private crossing, MP 6.58 on the Kenton Line. Do not sound whistle signal, GCOR 5.8.2(7), unless necessary to provide warning in an emergency, or notified that automatic warning devices are Malfunctioning, Disabled, or have an Activation Failure.
- 023 BRC CORA Update 2018-004 is effective 0001, October 25, 2018. CORA Update 2017-003 remains in effect.
- 024 At Clearing Yard, watch out for falling concrete in the vicinity of the Cicero Avenue bridge.
- 025 When leaving cars at the north end of the Third Rail Siding these cars must be left south of the private road crossing at MP 16.95
- 026 South Clearing Industrial District (SCID), South Lead, track OOS at Narragansett Avenue.
- 027 Hazardous walking conditions present at the following industries: 012, 031, 656, 682.
- 028 Watch out for close clearance from trees at Industry 012.
- 029 Use caution-uneven footing West class Hump end low side Tracks 0-17
- 030 Effective 1600/12.20.18, At Clearing Yard, the hand throw Switch on the North Thoroughfare in front of General Office Building is changed to a push button power operated switch.
- 031 At Hawthorne Interlocking , be on the lookout for open holes.
